Terms and Conditions:

1. Billable Weight

Shipments will be re-weighed/measured both on dimensional and actual gross weight at carrier operations depot or at the destination clearing hub. Leopards Express will charge based on the actual gross weight or dimensional weight whichever is higher.

Final declared weight given by the vendor will be considered as the billable weight.

2. Additional Charges

The rate excludes all other Surcharges such as: Value Added Services, Value Added Tax, Declared Value/Insurance, Government Levy, Export /Import Declaration, Insurance, Destination Duty & Taxes, Disbursement (Admin) Fee, Remote/Extended Area, Additional Handling, Large Package, Over Max Limit Fee, Bad Address, etc.

- AED 225 per package will be billed in addition to the shipping costs. A package is considered a "Large Package" when its length plus girth [girth = (2 x width) + (2 x height)] combined exceeds 300cm, but does not exceed the maximum size of 400cm. Large Packages are subject to a minimum billable weight of 40kg.
- AED 425 per package will be billed, in addition Packages with an actual weight of more than 70 kg, or that exceed 274cm in length, or exceed a total of 400 cm in length and girth combined [girth = (2 x width) + (2 x height)], are not accepted for transportation. If found in the small package system, they are subject to an additional charge. Packages exceeding 400 cm in length and girth combined are also subject to the Large Package Surcharge.
- Create shipping labels and or commercial invoices is at AED 4.60 per package above 50 pieces in addition to relevant shipping costs.
- AED 28 will be charged if incorrect or incomplete address is provided by the shipper and the correct address is in the same destination country
- AED 15 per package will be charged if any package exceed 122 cm in length or its second longer side exceeding 76 or any package with an actual weight greater than 32 kg.
- AED 15 admin charges will be charged for the collection of duty and other charges.

3. Service and Shipments Details

Please ensure that the right service level as stated above is indicated on the airway bill. Should a different service be used on the AWB, agreed rates will not apply and billing will be based on the contracted rates.





Also ensure that the commodity is as per the IATA mode of transportation allowed. Import Origin may restrict weight per customer per day. In all cases where the import inquiry is above the daily weight threshold, origin rates will apply and must be accepted by customer in writing before booking can proceed. Spot Rates are not automatically loaded for billing and must be accepted and AWB details confirmed in writing within 24 hours of the quote provided.

4. Transit Time

Transit time subject to space availability and flight connections.

5. Liability and Insurance

Leopards is not liable for any losses, consequential losses and damage. We recommend to choose for insurance which is 2% of invoice value or AED 200 whichever is higher. Unless confirmed the shipments will be moved without insurance.

6. Credit days

Leopards will generate shipment wise invoice and the payments should be done within 7 days from receipt of the invoice.

7. Validity of Agreement

The service agreement shall be in force for the initial period of 1 year and may renew this agreement for subsequent periods on mutual agreement, unless either party gives a 30 days prior written notice for termination to the other party. Such termination shall be without prejudice to the accrued rights and obligations of the parties prior to the date of termination.

8. Governing Law

This contract shall be governed by and constructed in accordance with the laws of Dubai U.A.E and in any case, dispute arising out of this contract, the matter will be referred to the courts of Dubai.
